

# Archery Outpost LLC - Liability and Photo Release Waiver

In consideration of being permitted to participate in any manner in the sport and activities of archer with Archery Outpost LLC (“AOLLC”), I acknowledge, appreciate, and agree that:

1. The risk of injury from the activity and equipment involved in archery or archery event is potentially significant, including the potential for permanent disability and death, and while particular safety practices, supervision and personal discipline will minimize this risk, the risk of injury does exist;
2. I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of those persons released from liability below, and assume full responsibility for my participation; and,
3. I understand the activities of archery are potentially dangerous. I also understand that all participants must comply with all rules and regulations. If I observe any unusual or unnecessary hazard during my participation, I will bring such to the attention of the nearest AOLLC representative as soon as practical; and,
4. I, for myself and behalf of my heirs, assigns, personal representatives and next of kin, hereby release and hold harmless Archery Outpost LLC, the owners and lessors of the premises used to conduct the archery activities, their officers, officials, agents and/or employees (“Releases”), with respect to any and all injury, disability, death, or loss or damage to person or property, whether caused by the negligence of the releases or otherwise, except that which is gross negligence of wanton misconduct.
5. I understand and agree that this Release of Liability Waiver Agreement covers each and every archery activity and event in which I participate in hereafter.

## Photography and Video Release

6. I hereby grant AOLLC permission to use photographs or video footage in any and all publications for marketing or promotional purposes, including web site or Facebook entries, without payment or any other consideration in perpetuity.
7. I hereby authorize AOLLC to edit, alter, copy, exhibit, publish or distribute these photos or videos. I waive the right to inspect or approve the finished product, including written or electronic copy, wherein my image appears. Additionally, I waive any right to royalties or other compensation arising or related to the use of the photograph.

I hereby hold harmless and release and forever discharge AOLLC from all claims, demands, and causes of action which I, my heirs, representatives, executors, administrators, or any other persons acting on my behalf or on behalf of my estate which may have or may have by reason of this authorization.
